Reference: Characteristics of a Bread & Roses Grantee

Bread & Roses Community Fund has been making grants to grassroots organizations since 1977. Organizations that exemplify the best of what makes a Bread & Roses grantee have many of the following characteristics:

- 1. People most affected by racial and economic injustice are leaders, and the groups build broad leadership bases that can survive when key leaders step down.
- 2. They understand power differences based on race and class and can talk about how they are trying to challenge those power imbalances both within their organizations and in their communities. They have a shared vision for what that change looks like and can articulate that vision.
- 3. They prioritize ongoing education/consciousness raising for constituents and allies that broadens their base.
- 4. There is a plan, including short term and long term goals that are specific, achievable, and relevant to the problem they seek to address and the overall vision for justice.
- 5. The group is knowledgeable about other organizations working on the same issue, and is able to work in coalition across movements, issues, and communities to amplify impact.
- 6. Because of their commitment to challenging power and prioritizing the leadership of marginalized people, these groups are less likely to be funded by more traditional funders; therefore, funds from Bread & Roses Community Fund are critical to seeding or sustaining the work.
